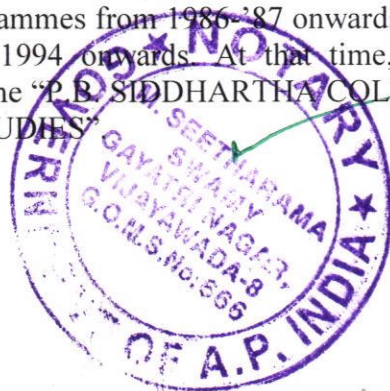
### AFFIDAVIT

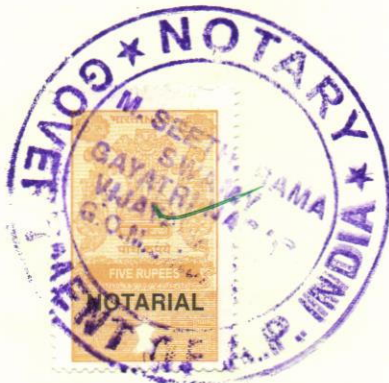
