#### 1. EXECUTIVE SUMMARY

#### 1.1 INTRODUCTION

Parvathaneni Brahmayya Siddhartha College of Arts & Science started in the year 1975 by as Private with UGC recognition under **2(f)** and **12B**. It is the first offspring of "Siddhartha Academy of General & Technical Education" started in the year 1975. The college with strength of 3565 students and 127 faculty members in which 38 members have Ph.D became the one of the prominent colleges in AP. The college is offering 31 diversified programmes from the academic year 2023-'24, out of which 8 are Post Graduate Programmes and 23 are Under Graduate Programmes. Apart from that the college is offering one year Diploma programme in Yoga Education and one certificate course in Hotel Management.

The college has been enjoying full academic autonomy since the academic year 1988-89. The college has been in collaboration with TCS, ICT Academy, APITA (Andhra Pradesh IT Academy) in conducting academic programmes and with APSSDC (Andhra Pradesh State Skill Development Corporation) for skill programmes and placements. - Poor language competence of the students, as most of them hail from marginalized families, sometimes even first generation educated students, completing their education in mother tongue, lacking the communication skills or sometimes with poor cognitive skills. This leads to an unsatisfactory level academic progression, particularly in the first two semesters. However, planned intervention programmes making substantial difference and greatly enhances the communication abilities in subsequent semesters.
- Advanced pedagogical methods are to be implemented. Lack of customized LMS.

#### **Infrastructure and Learning Resources**

The institution strives to provide its students an optimum learning environment. The management is dedicated to provide excellent infrastructure and instructional components to achieve that objective.

#### **Physical Facilities:**

There are 67 moderately furnished classrooms, 53 with LCD projectors. The institution features a media facility with a camera and software to record video classes and produce MOOCs. A 250-person Webinar Hall for live streaming events. The campus has an elbow room for brainstorming and sharing ideas. This room has everything needed to organise sessions. Institution's Seminar Hall holds 120 people. The college has a 60-student e-class room in addition to the elbow room and webinar hall. Modern lab equipment lets students easily conduct experiments and projects. Play Ground with flood lights and Indoor Stadium with LED lighting and wooden surface are appropriate for day and night competitions. Fitness demands are met by the 32-station gym. Yoga Hall holds 40 people each class. An Auditorium with 1000 seats, acoustics, a well-elevated stage, curtain change facilities, and a foyer is available at the college. We have two 125KVA generators and two 700 lit/hour RO water plants that produce drinking water 24/7. An Open Dais hosts official and casual events.

#### **Library as a Learning Resource**

The East block houses 6,000 sq.ft **Central Library** and 2,400 sq.ft **Reading Room** with a vast collection of over 94,452 volumes of textbooks, reference books, journals. Library has subscription to INFLIBNET & N-List through which the library provides access to many e-journals and e-books. The library's automation with LIBSYS-3.3 offers remote OPAC access, user holdings tracking, and reservation requests. The library offers audio-visual reprographic centre, photocopier service, and internet access.

#### **IT Infrastructure**

The institution is equipped with 53 LCD projectors, 30 printers, 2 ADF scanners, 6 Copiers, 30 Campus wifi points, 5 servers, 2 Interactive panels, 3 TV monitors and 32 laptops for academic and administrative purposes. The campus-wide LAN, with 720 computer systems connected to 11 servers, 385 Mbps high speed internet bandwidth along with Wi-Fi.

The college has well-defined policies for maintenance of all the facilities. The college has substantially invested in its infrastructure and educational resources, establishing a highly sophisticated learning environment for its students.

	founders of the college articulated a profound vision
	for the organization, and subsequent cohorts of
	faculty members have diligently endeavored to
	actualize this vision. The vision statements
	articulated the aspirations of the 50-year-old
	organization in addressing the evolving requirements
	of future students. The institution has been operating
	in a way that elucidates how its convictions and
	foundational principles can facilitate the education of
	students from this predominantly agrarian region,
	fostering their development within a comprehensive

environment. The comprehensive education pursued

at this institution focuses on nurturing the full spectrum of each student's cognitive, emotional, social, physical, artistic, creative, and spiritual capabilities. The College has been diligently working to involve students in the educational process while promoting both individual and communal accountability. This distinctive multidisciplinary approach allows students to engage with and investigate a variety of subjects or curricula across different fields of study. We hold the conviction that education transcends any singular discipline. For example, our computer science students engage in a course focused on humanities, while those studying ethics and the arts also acquire knowledge in computer and soft skills. Multidisciplinary & Interdisciplinary programmes/courses are always very useful and helpful to meet the needs of the society, industry and to make the students job ready. It is always the culture of the institution to gear up the students professionally, socially & ethically ready. In view of this, the institution is offering a good number of multidisciplinary programmes. List of Multidisciplinary Programmes: 1. BBA (Business Analytics): Management courses integrated with technology courses. 2. B.Com. (e-Commerce): Commerce courses integrated with technology courses. The Domain Specific Programmes: 1. B.Sc. (Mathematics, Statistics, Computer Science): 2. B.Sc. (Computer Applications, Mathematics, Electronics) 3. B.Sc.(Mathematics, Statistics, Data Science), 4. B.Com. BFSI (Banking, Financial Services, Insurance); Commerce courses integrated with management courses, 5. B.Sc. (Artificial Intelligence and Machine Learning): Technology courses integrated with Mathematics and Statistics courses. 6. M.Sc. (Computational Data Science): Technology courses integrated with Mathematics and Statistics courses. The institution always encourages faculty to carry out interdisciplinary research. The outcomes of such research are always beneficial for the society. In recent academic years i.e., 2019-2020 & 2020-2021, a good number of open elective courses are offered to the students of PG. #### 2. Academic bank of credits (ABC):

The Academic Bank of Credits is an initiative established by the Government of India as part of the National Education Policy (NEP) 2020. This initiative includes measures to establish a digital infrastructure that would facilitate the transfer of academic credits obtained by students from higher education institutions nationwide. Moreover, it is understood that the ABC will be assigned the duties of opening, closing, and validating the individual academic accounts of students. It will also be responsible with collecting pertinent information on the academic credits obtained by students from their different higher education institutions, verifying the credits, transferring or redeeming these credits, and promoting them as necessary among its stakeholders. The UGC and Ministry of Education (MoE) state that students must manually create an account with the Academic Bank of Credits of India and adhere to the Standard Operating Procedure (SOP) provided by the ABC, which includes a unique ID for each student's account. The academic bank will commence operations in the 2021-2022 academic year. As an autonomous institution certified by NAAC with a "A+ Grade," the college is authorized to establish an Academic Bank of Credit for its students. Nevertheless, the college is linked with Krishna University and is awaiting the initiation of a section on their website, as well as guidance on how to participate in the program. The college acknowledges that the initiative is significantly advantageous for students, encompassing all types of courses provided by Higher Educational Institutes recognized by the University Grants Commission (UGC), including undergraduate programs, postgraduate programs, Ph.D. programs, diploma courses, and certificate courses. The Institution will inform students that the credits in their individual accounts will significantly expand their academic and professional options. Moreover, individuals may withdraw from their institution at any year or semester and exchange the credits accumulated thus far for a certificate or diploma, contingent upon eligibility. They will also have the opportunity to redeem the credits and reenroll in the same institution or another of their

choosing, either concurrently or at a later date, and resume their study from the year or semester in which it was interrupted. It will ensure that the time a student has invested in higher education is not wasted if he or she chooses to withdraw from the course or institution for whatever reason. Once the affiliating university initiates the program, the college will subsequently pursue it on its behalf. Nevertheless, the institution has registered with the Academic Bank of Credits, and student registrations are already underway.

#### 3. Skill development:

The Government of India and the UGC have recognized that skills and knowledge are important to economic growth and social progress, particularly in a growing nation such as India, which has a significant young population. Currently, there exists a disparity between demand and supply in the country. The Indian economy requires a greater quantity of trained labour than is now accessible. To enhance the higher education system, the Government of India (GOI) and the UGC have introduced a National Vocational Education Qualification Framework (NVEQF), which was subsequently integrated into the National Skills Qualifications Framework (NSQF). Recognizing the significance of skill development among students and the need for a largescale workforce prepared for employment, the Commission (UGC) initiated the B.Voc. Degree program to broaden the scope of vocational education and facilitate vertical mobility for students enrolled in Community Colleges' Diploma programs to transition to degree programs in Universities and Colleges. Parvathaneni Brahmayya Siddhartha College of Arts & Science has started a Certificate Course titled 'Hotel Management & Catering Technology' in the academic year 2023-24, motivated by a desire to participate in the initiative of the GOI and UGC. The institution recognizes that the Skill Development Courses facilitate the execution of certain activities with a high level of expertise. The stakeholders of the college assert that in this rapidly evolving environment, training in a skill development course provides a significant edge and can favourably influence the prospects of a trained student. 4. Appropriate integration of Indian Knowledge system (teaching in Indian Language, culture, using online course):

The Indian knowledge system encompasses the wisdom transmitted to contemporary generations from both ancient and modern India. The NEP instructs educational institutions to include Lok Vidya into the curriculum. The indigenous and traditional learning methods inherited from our ancestors will be addressed in courses such as physical sciences, yoga, sports, games, governance, and politics within Bachelor of Arts programs, as well as in community service and environmental conservation. The APSCHE and the affiliated

institution will endeavour to develop certificate courses or modules in programs that permit such offerings. The cultural division of the Siddhartha Kalaapeetam has been invigorating students via many events that embody Indian culture and dance. The literary club has been organizing competitions in art, essay writing, elocution, and debate. The group also organizes poetry competitions. Occasionally, literary figures are asked to engage with the faculty and students, imparting the essence of Indian languages and literatures. Likewise, the Women Empowerment Cell (WEC) organizes competitions to showcase the artistic talents of female students. WEC occasionally conducts motivational programs for individuals and groups. Literary activities, reading habits, painting, and rangoli competitions are organized to showcase the intrinsic abilities that have historically existed in India. It is anticipated that these events would enhance cultural identification, awareness, and team spirit among students, therefore fortifying the social fabric of the region. In the forthcoming days, the institution intends to assess the possibility of providing all these as online certificate courses for both students and external participants. By providing lectures and workshops, the college promotes the spread of Yoga through diploma program. Programs as such seeks to increase understanding and draw attention to the importance of traditional knowledge systems in modern culture. In order to foster moral and ethical values, the College integrates passages from 'Srimad Bhagavad Geetha' within the curriculum of all postgraduate programs. Hindi, the national language, and Telugu, a credit-based vernacular language, are necessary courses for all first- and second-year degree students. Every course is worth four credits. Through participatory methods, this allows students to have a greater understanding of Indian culture. 'Indian Culture and Science', the Life Skills Course, is part of the curriculum, and its goal is to preserve and promote Indian customs and culture. With effect from the academic year 2023–2024, the institution has added courses which focus on Interdisciplinary and Multidisciplinary approach to create a favorable atmosphere for the advancement and sharing of knowledge and technology within the Indian Knowledge system.

5. Focus on Outcome based education (OBE):

Outcome-based education (OBE) has emerged as a

prevalent term nowadays. The Grants Commission (UGC) noted in its document, https://www.ugc.ac.in/pdfnews/4598476 LO CF-UG.pdf, that the core principle of the learning outcomes-based approach to curriculum planning and development is that higher education qualifications, such as Bachelor's Degree programs, are conferred based on the demonstrated attainment of outcomes (articulated in terms of knowledge, understanding, skills, attitudes, and values) and the academic standards anticipated of graduates from a program of study. Learning outcomes delineate the knowledge, comprehension, and competencies that graduates are anticipated to possess upon the completion of a certain academic program. Generally, OBE is seen as a student-centered pedagogical approach. In Outcome-Based Education (OBE), course delivery and evaluation are strategically designed to attain specified objectives and results. It emphasizes the assessment of student performance, specifically results at various stages. Outcome-Based Education (OBE) seeks to distinctly concentrate and structure the educational framework on the fundamental requirements for all students engaged in a particular program. It is commonly anticipated that a student graduating from an academic institution must be capable of effectively presenting, defending, and demonstrating their learning experiences. Consequently, PBSCAS conducted a good number of workshops from 2017 to till date in order to unite academics in sharing their insights regarding the critical concerns pertinent to comprehending and executing Outcome Based Education. During the workshop, participants deliberated the implications of the phrase "outcome-based education" in relation to the subject matter. Identified the essential terminology and concepts pertinent to Outcome-Based Education (OBE) and delineated the foundational principles of the outcome-oriented strategies are implemented in the institution, along with the observed outcomes. Additionally, the institution examined the socioeconomic transformations at regional, national, and global levels while developing the OBE instructional models and methodologies accordingly. The Institution has resolved to evaluate the trends or modifications in classroom interaction, program alignment, external accountability, and

system/syllabus transformation when the findings from the workshop are applied in the institution and classrooms. The College has also equipped itself to address the obstacles of OBE implementation with rationality. The Institution has established an ecosystem of Outcome-Based Education. Workshops and seminars are organized to educate teachers on the fundamental principles of Outcome Based Education. Given the significance of Outcome-Based Education in the current context, the departments have developed syllabi that align Course Outcomes with Programme Outcomes. The Programme Educational Objectives are formulated in accordance with the Institution's vision and purpose statement. The acquisition process includes both direct and indirect means. Indirect assessment is accomplished by a course exit survey administered at the conclusion of each semester, use a five-point scale. Weightages of 30% and 70% are allocated to indirect and direct attainment techniques, respectively. At the conclusion of the program, the assessment of Programme Outcome achievement was conducted on the extent to which Course Outcomes are aligned with Programme Outcomes, utilizing a three-point scale: Low(1), Medium(2), and High level(3).

#### 6. Distance education/online education:

Online education and Open Distance Learning (ODL) provide students an excellent opportunity to integrate education into their lives, effortlessly. This allows students to learn at their own pace and at a time that suits them best. Parvathaneni Brahmayya Siddhartha College of Arts & Science, an Autonomous Institution aligned with the National Education Policy (NEP), is diligently preparing to provide courses via online platforms in the near future. The College is adequately equipped and prepared to engage in Open Distance Learning (ODL) courses and online education. The College houses a longstanding e-content creation room. Students who register as members of the SWAYAM-NPTEL Local Chapter will have the opportunity to gain knowledge by enrolling in and participating in massive open online courses (MOOCs). This encompasses esteemed institutions like the IITs and NITs. Postgraduate students must enroll in at least one massive open online course (MOOC) offered by the SWAYAM-NPTEL Local Chapter. The credits earned in these courses contribute to both semester

grade point averages and cumulative grade point averages. Students are encouraged to enroll in massive open online courses (MOOCs) offered through several platforms, including Coursera and Edx. etc. The Marks Memos indicate that supplementary credits have been assigned for specific class areas.

**Response:** 

The institution is very careful not to create in students any psychological division and labelling them as particular type of learners. However, it is aware of general scholastic abilities (intelligence) of students. Teachers and mentors make a close observation of students' learning styles. Students from a variety of socioeconomic backgrounds attend the institution, particularly those who hail from rural areas. The college established a system to track and accommodate each student's unique learning needs in order to address the issues.

In addition to orientation regarding their respective curriculum, the college's various curricular, cocurricular, and extracurricular activities, opportunities and facilities, etc., are also briefed to freshers along with the teaching and learning methodologies used in the curriculum during the Student Induction Program.

Throughout each semester, the College uses test scores, presentations, assignments, lab skills, and other methods to continuously evaluate students' academic progression. It has also taken the necessary steps to improve each student's performance. Beginning with the first semester, teachers manage their classes while conducting formative assessments of their students. Students are classified as slow learners, if they require one or more repetitions of the same lecture as they unable to understand the content taught in class. However, advanced students respond to inquiries promptly. In order to classify both kinds of learners, their prior academic success is also taken into account. Finding a student's strengths and shortcomings is also aided by internal assessments and class exams.

#### **Initiatives for slow learners**

Questions from the previous year as well as question banks covering all disciplines are distributed to students to the identified slow learners. When it comes to key questions, students are given multiple opportunities to practice. Both peer learning and peer tutoring are supported in the context of peer teaching. For the purpose of addressing the concerns of slower learners, mentors make use of the expertise of more advanced students.

Additionally, YouTube lessons on a variety of subjects are available on college websites.

Coaching for Remedial Needs: Additional remedial lessons are organized for students who are at a slower pace. The improvement of their performance can be aided by the repetition of important topics. Their level can be raised with the assistance of counselling and additional teaching.

Walk with a Mentor: This program is designed to help average and above-average performers get better results by enhancing their academic achievement, communication abilities, and self-confidence, hand holding them by mentors.

#### **Initiatives for Advanced Learner**

The college gives them more reading material, resources, and research-focused assignments to broaden their knowledge and skills.

The college has a system in place to encourage advanced students to sign up for NPTEL/SWAYAM in order to finish a variety of courses and expand their knowledge and abilities.

# The institution adopts effective Mentor-Mentee Schemes to address academics and student-psychological issues

#### **Response:**

The Parvathaneni Bramhayya Siddhartha College of Arts and Science has established a rigorous mentormentee system. Students are paired with more experienced persons, who are referred to as mentors, in order to offer them with direction, support, and inspiration. Mentoring is a structure that brings together students and teachers. Every single academic mentor is assigned a group of mentees that consists of around 20-30 students. Because it encourages students to grow in all aspects of their being, this has shown to be beneficial to the institution. Additionally, it encourages the formation of responsible citizens who demonstrate admirable conduct and responsibility in their academic endeavours as well as in their dealings with other people. A shared WhatsApp group will be established between the mentor and the mentees that they have allocated to them, with the faculty member serving as the only administrator of the group. Notifications of critical importance, including but not limited to insufficient attendance, instances of indiscipline, parent-teacher conferences, and test failures, will be sent within the group. It is necessary for the mentee to make arrangements for their parents to communicate with the mentor at the parent-teacher conference before addressing the Principal. In the course of the meeting between the teaching staff and the parents, the mentor will, in the presence of the Principal, provide the parents with information on the academic and behavioural characteristics of the specific mentee. A registration is maintained to record information about the mentee, and the signature of the parent will be collected from inside the registry. Through the use of the Mentor-Mentee method, the organisation has been able to accomplish a great deal of success, some of which are detailed below.

- Mentors with industry knowledge gave professional guidance, aided in CV enhancement, and offered insights into potential career paths.
- Mentors provide targeted instruction on study techniques, time management, and resolving academic challenges.
- The mentors acted as a platform for the individual's personal concerns and offered direction via their ongoing relationship.
- Mentoring has fostered a delicate sense of connection and belonging among students inside the institution, resulting in enhanced student engagement.

#### The implications:

#### **Response:**

Examination Management System (EMS) in the college has improved due to IT integration and modifications to examination processes including Continuous Internal Assessment. These changes streamlined and modernized several examination system components, boosting security, confidentiality, accuracy, efficiency, and transparency.

#### Reforms in the examination procedures and processes

By using PHP software, which keeps track of student information, exam information, topic information,

fee information, and exam scheduling information, the college's examination processes are now completely automated.

The college's exam system has several important components, such as:

- 1. Automated procedure: The college website provides pertinent information, including schedules, notifications, and results, and the entire test procedure is entirely automated. The results of the semester-end exams are published on a different portal Admin PBSCAS (siddharthaexam.in) which is easily accessible to students.
- 2. Timely Results Declaration: In order to provide students with a timely outcome, the results of the Semester End Examination are announced within 30 days from the last exam.
- 3. Revaluation of Answer Scripts: By paying the required fee, students can get their answer scripts revaluated. This service is available to the student within a week to 10 days of the results being announced.
- 4. Supplementary tests: All semesters include supplemental tests that are administered soon after the results are announced, providing students with a chance to raise their performance.
- 5. Strict Actions against Malpractice: The college takes strong action against unfair practices in theoretical and practical exams. It is a malpractice crime for a candidate to try to influence teaching or non-teaching personnel for their own benefit. If misconduct is discovered at any point, it is dealt with harsh penalties.
- 6. Barcoding of answer scripts: To combat cheating during test evaluation, we added barcodes to answer scripts in the academic year 2022–2023.
- 7. Activity: Student participation in any one of the listed Co- curricular activities like participation in seminars/ workshops/conferences as well literature review etc., is given due marks in CIA.
- 8. The internal component of CIA for UG has been increased from 25 to 30 marks from the academic year 2022-23.

### IT Integration:

IT integration has accelerated the examination process, improving efficiency and transparency. Various examination operations, such as capturing internal and external marks, posting results, and creating mark memos, have been made possible through the use of ICT, providing greater convenience to all stakeholders. Using PHP software for calculating SGPA, CGPA, and grades improves accuracy and reduces human error.

The EMS enables effective communication among the college administration, faculty, and students. It delivers automatic notifications for examination schedules, changes in timetable, submission deadlines, and result announcements to ensure timely information dissemination.

The IT-integrated EMS allows for effective data administration and analysis. It maintains and organises student records, examination data, and performance metrics, which are then utilized to generate meaningful reports.

The Physical infrastructure in the college is adequate, appropriate, supportive and sustainable to students for their academic pursuit and holistic development.

The college has Mother Theresa Block (South), Sir C.V. Raman Block (West) and Rabindranath Tagore Block (East), Sri Venkateswara Prayer Hall, Dhyan Chand Block, Patanjali Block and Koutilya Block. There are 67 Classrooms which are spaciously built, properly ventilated, adequately illuminated with day light and with comfortable sitting desks. A lectern along with stage facilitates lecturing. Wide corridors and wide sloped staircases allow students to stroll on en-block. State-of-the-Art Laboratories are established in all departments.

#### IT infrastructure

**47 Classrooms** are equipped with permanent LCD projectors 2 with **Interactive boards** and 4x8 feet white boards facilitate conventional teaching. The campus is **Wi-Fi enabled**, with 385 Mbps bandwidth network. Faculty adopts LMS and use Google classrooms to communicate with students.10 computer labs with LAN connectivity through 11 servers enable ICT teaching and practice. Central Research Lab, Media centre, Studio, Data Centre, Idea room/Elbow room are the other important facilities in the college.

Auditorium with 1000 Accommodation, A **webinar hall** with and **A media centre**with 120 accommodation, facilitate to interact with resource persons online\offline. Studio facility in the webinar hall facilitates the video recording of the subject content.

**Placement Cell** has adequate cubicles for personal interviews and space for group discussions duringplacements.

A well-furnished Cafeteria caters the students and staff with delicious eatables and beverages at

nominal rates.

**Lifts and** Ramps facilitate the disabled to reach their destiny points with minimum inconvenience.

The college buildings are equipped with Fire Safety system, Two 125KVA generators, UPS for labs, Restrooms for both genders, Two 700 litres/hour capacity RO plants, Bank Branch, Post Box, health centre, First-Aid room. College provided shared accommodation to the students.

#### The College has adequate facilities for sports, games and cultural activities

#### **Open Play Ground**

A spacious even playground exists on the campus for games such as Cricket, Football, Volley ball, Basketball and Athletics. **Floodlight facility is available to the Basketball court**. Running track around the play field is used by the students. Shot-put sector, Harvard Footsteps are also available.

#### Indoor Stadium

Indoor Stadium, houses two wooden Shuttle Badminton courts and Table – Tennis table, Weight Lifting space etc. Rest rooms and living rooms are also available in the indoor stadium forthe players.

#### **Library Information Centre**

The Central Library of Parvathaneni Brahmayya Siddhartha College of Arts & Science serves as a vital hub for academic and research endeavors. Central Library is located in ground floor of Rabindranath Tagore Block with 6000 sq. ft. area and a reading room with 2100 sq. ft. area.

With a vast collection of over 94,452 volumes, the library offers a diverse range of materials to cater to the needs of students, faculty, and researchers.

The college has a prestigious computerized central library with an excellent collection of textbooks, reference books, journals, periodicals, magazines, databases, encyclopedias and dictionaries. Books related to Career guidance, Career clippings, Display of new arrivals etc. personality development are at the reach of students to improve their competitive skills. The faculty members can indent the list of books to the librarian through the purchase indent forms.

The Central Library has 249 rare books, 68 Journals, 40 Magazines and 40 Ph.D./M.Phil. Dissertations in different disciplines of Science, Humanities and Languages are rare sources particularly for the research scholars. Also the library consists of Manuscripts of professors like great mathematician Srinivasa Ramanujan for the benefit of students and staff and it

The library transitioned to the web-based integrated library management software "NewGenLib" in 2017, including remote access to the Online Public Access Catalogue (OPAC), user holdings tracking, and reservation requests.

#### Reading room

A free internet center in the library caters to the students from 8 am to 8 pm free of cost. Students and staff browse the Internet here to supplement their subject knowledge.

# The digital library provides the following services to the faculty and students:

**N-List (UGC/INFLIBNET):** The college has registered staff members and some students with INFLIBNET N-List, granting them access to a vast collection of e-journals and e-books.

- **DELNET Database:** The library has been using the services of DELNET since 2021.
- **NVDA**: The library has been providing NVDA software which allows blind and vision impaired people to access and interact with the Windows.
- The Library is also a member in National DigitalLibrary (https://ndl.iitkgp.ac.in/) (NDL). All our staff and students have enrolled their membership to access the huge resources, offered by NDL, freely.
- Fifteen desktops inside the Library are available for access by the staff and students. Internet access is provided via broadband and Wi-Fi.By leveraging technology, the library has become a

valuable resource for the college community, supporting learning, research, and academic growth.

The library follows a strict maintenance policy for equipment purchases and maintains a detailed accession register for all books acquired. Books are barcoded and entered into both manual and digital databases. Circulation is facilitated through barcode technology.

The library's core responsibilities include regular stock monitoring, preserving rare books, efficient book circulation processes. On an average, the library receives 500 visitors per day, with approximately 100 books being issued daily.

Along with central library each department maintains Department library housing 200 to 500 textbooks/reference books. These books are made available to students for referencing or learning.

### **Facilities for E-Content Development**

1.**Media Centre**— Media Resource Centre (MRC) consists of a dynamic team to capture the moments of all the activities inside the campus. The team gives effort in capturing the meetings

- 1. Audio Visual Centre The Audio Visual Centre of the college was established with the gadgets like Canon DSLR D80 still camera, Sony MX 250 Video camera and audio equipment. The Audio Visual Centre is used as a multitasking laboratory in the digital and multimedia production. It is used as Chroma Studio, Photo Studio, Story-boarding, Editing and mixing center. The Audio Visual center the ultimate facility to develop e-learning materials by the faculty in their thrust for student centric pedagogy.
- 1. Lecture Capturing System (LCS) The college has facility of Lecture Capturing System (LCS) with zero echoes. Teleprompter is another interesting gadget available in the room. #### **Role of Director and Office Superindent:**

The college has laid down the procedures for various categories of movable and immovable assets. The responsibility of maintaining the assets of the college is assigned to the Office Superindent of the college. He carries out regular inspections of all facilities, ensures timely maintenance and monitors the functioning of the designated staff. The Director of the college facilitates the quick approvals for doing work from management.

#### **Campus Maintenance:**

Cleaning and maintenance of classrooms, seminar halls, laboratories, departments, library, corridors, garden and the temple inside is done by a team of sub-staff of the college.

#### **Laboratory Maintenance:**

After every laboratory practical work, the **laboratory assistants** do disposal, cleaning and setting right the instruments.

Installing, Maintaining and **Repairing of Electrical** wiring and lighting systems is done by the electricians of the college. They also look after power distribution points from transformers, solar power generation, water pumps, RO plant and electrical gadgets of the college.

#### Utilization of Physical, Academic and Support facilities:

The **classrooms** are utilized for teaching and learning purposes. As the classrooms are well equipped with lighting and fans, any grievance from the learners will be processed immediately.

Sponsorships are sought from individuals and corporate for FDPs, cultural events and fests.

#### **Optimal Utilisation of Resources (Utilization of Funds)**

- A Finance Committee has been constituted to plan the utilization of funds optimally for various recurring and non-recurring expenses
- The Purchase Committee seeks quotations from vendors for the purchase of equipment, software, computers, books, membership subscriptions, AMCs etc.
- The quotations are scrutinized by the Finance and Purchase committee before a final decision is made based on parameters like pricing, quality, terms of service, etc.
- The Principal, finance and purchase committees along with the accounts department ensure that the expenditure lies within the allotted budget. The intervention of the management is sought in case the expenditure exceeds the budget.
- The imprest amount will be utilized to meet day-to-day operational and administrative expenses and maintenance of the fixed assets.
- The administrative and financial approvals are taken from competent authority i.e. Governing Body as per policy and guidelines.
- The various heads for which budget is prepared and funds allocated are approved by the finance committee and ratified by the Governing Body.

#### **Response:**

**The PBSCAS** has the budgetary control system to monitor the effective and efficient use of financial resources. Many reforms were brought in the financial administration of the institution.

#### **Finance committee**

Financial committee headed by the principal and representations of the management, teaching staff and administrative staff will be sought budgetary requirements from various departments and cells. At the beginning of the academic year the annual budgets are prepared, reviewed and approved by the finance committee. The finance committee has fixed the limits of total recurring and non-recurring expenditures based on the income and resources of the institution.

#### **Internal Audit committee**

The institute regularly follows internal and external financial audit system. The institutional accounts are audited regularly by both internal and statutory audits. Qualified internal auditors have been permanently appointed and a team of staff under them verify all vouchers of the transactions that are carried out in each financial year. The internal auditor shall evaluate and confirm the effectiveness of internal system of accounting. So far there has been no major objection in financial auditing, minor errors or omissions when pointed out by the audit team are immediately corrected / rectified and precautionary steps are taken to avoid recurrence of such errors in future.

#### **Eternal Audit:**

The external auditing is done by a Chartered Accountant, specially designated for this purpose. External audit is also carried out on an elaborate way on quarterly basis. All the audited statements for the past years are uploaded in college website to maintain transparency in financial matters.

The College maintains transparency in the financial records and gets financial audits done regularly. It has a full-time accounts department and in house internal audit team since inception to ensure proper and timely maintenance of accounts and audit compliances. For each financial year they check and establish the accuracy of the financial statements and related accounting policies/standards are as per statutory requirements. The income and expenditure of the institution are subjected to regular internal and external audit. External auditor is appointed by the institution who executes the statutory audit.

#### **Utilisation Certificates**

All Utilization Certificates to various grant giving agencies are also certified by the external auditor time to time. Since inception, till the financial year ending 2022-2023, all the annual financial statements has been certified by the external auditors. Last audit was carried out in the month of 16th September 2023. No irregularities were found in the audit.

The institution has been engaging qualified chartered accountants and experienced audit expertise to conduct the external financial audit. The auditor can verify all the finance related income and expenditure statements, documents like bill books, cash books, ledgers, other financial statements etc.

The Commissionerate of Collegiate Education delegated Government auditor also check the college financial accounts. Random audit will be conducted by the Auditors of the Accountant General Govt of India. They also verify the college accounts relating to Government grants, UGC grants and its utilization.

The P.B. Siddhartha College of Arts & Science IQAC has been improving academic and extracurricular quality by internalising a culture of excellence and institutionalising best practices within the Autonomous System to improve academic and administrative performance.

Two notable practices established due to IQAC activities during the past five years are:

#### **Practice 1: Curriculum Enrichment**

In alignment with the IQAC initiative, the process of Curriculum Development and Enhancement is reinforced by the frequent convening of Board of Studies (BoS) meetings each semester, including industry and university experts, and subsequently validated by the Academic Council. Guided by the IQAC, these sessions enable ongoing syllabus revisions, the incorporation of new technology, and the resolution of deficiencies discovered in the job market.

- Full-length project in one semester: All undergraduate students are required to complete an internship or project for one semester.
- Offering Value-Added Courses for Skill Development: The college has launched over 50 value-added courses to provide students more information and abilities as part of our IQAC mission. These courses are designed to complement the core curriculum and provide students with practical skills that are directly relevant to their fields of study.

• Applying Bloom's Taxonomy: IQAC programs concentrate on using Bloom's Taxonomy to improve students' cognitive capacities, with a particular focus on cultivating higher-order thinking abilities. In order to improve student learning and satisfaction, IQAC activities also include the efficient formulation of Program Outcomes (POs) and Course Outcomes (COs). Program results and program-specific outcomes are linked onto the course outcomes. Knowledge levels are also used to identify each result.

#### **Practice 2: Student-Led Activities**

Student-led activities foster leadership traits, enhance learning abilities, encourage diversity in decision-making, polish professional and ethical standards, and cultivate change agents in their workplaces. They facilitate the development of self-motivated leaders by independently organising student meetings. Every department organises one or two regional tournaments within their respective domains. The nomenclature varies with the situation (i.e., KURUSKETRA, VIBHAVA etc.,)

In addition to these activities, they organize exhibits and intramural tournaments on various occasions. They engage in literary, cultural, NCC, NSS, yoga, and sports events according on their preferences. The NSS volunteers and other students provided invaluable assistance during the COVID pandemic by delivering meals to isolated areas inaccessible to the elderly. The IQAC consistently endeavours to evaluate the teaching, learning, and assessment processes, as well as the pedagogical methods and technologies used in their execution.

The prominent curricular and assessment projects undertaken by the IQAC are 1) Regular Evaluation of Educational Practices and 2) Enhancement of Quality Research.

IQAC created an system for evaluation of design, development and delivery of quality education to the students. The curriculum is designed with involvement of best minds from academics, industry and feedback from all stake holders. A radical shift brought into curriculum of undergraduate programmes from Three Major programmes to Single major programme with one minor.

All 30 programs (undergraduate and postgraduate) provided by the institution are consistent with its vision and mission. The Curriculum is aligned with Bloom's Taxonomy Levels, providing learners with clarity on Programme Outcomes, Programme Specific Outcomes, Course Outcomes, and Specific Learning Outcomes.

The institution upholds a 90-day academic calendar plan to guarantee prompt syllabus completion. Course content is delivered as per pre-drafted Teaching Plan. **Continuous evaluation** enhances the Formative Assessment Loop in alignment with our IQAC effort, we diligently.

The college adopts Pedagogical Innovations utilising online technologies in delivering content. ICT-enabled teaching and assessment helped in COVID period also met contemporary educational requirements.

The IQAC provided directives for using PowerPoint presentations, integrating platforms such as Google Classroom, Zoom, and interactive digital technologies to enhance student engagement and involvement.

The IQAC developed a mechanism to evaluate the achievement of Academic Performance Indicators of faculty Self-Assessment and Appraisal format.

## 2. Enhancement of Quality Research

#### **Response:**

Parvathaneni Brahmayya Siddhartha College of Arts & Science is dedicated in establishing waste management systems to protect the environment. The college is able to manage all types of waste management methods mentioned below, except Biomedical waste which is not relevant to the college.

The college is maintaining different waste management systems in the following ways.

# **Solid waste management**

The College is implementing comprehensive strategies to handle both biodegradable and non-biodegradable wastes. Robust waste management system on the campus includes vermicomposting, Indore composting, NADEP composting generating manure from biodegradable wastes. The manure is utilized for green cover-up on the campus.

Emphasis on waste segregation at the source with marked bins for biodegradable and non-biodegradable waste encourages stakeholders to participate actively in waste management practices.

Vermicomposting method using earthworms produces high-quality manure. A conventional composting technique facilitates the natural decomposition of organic matter in bulk quantities. Pipe Composting is an innovative method for urban settings, where space is limited, allowing for effective waste decomposition without requiring extensive land use. Nadep composting and Indore composting, techniques for bulk composting are also implemented for solid water recycling. Our solid waste

management practices are regularly monitored and evaluated to identify areas for improvement and ensure compliance with environmental standards.

## **Liquid Waste Management**

The college focuses on the recycling of RO water waste, AC condensed water, Tank overflow water, rainwater harvesting through percolation pits.

**RO** waste water/Tanks overflow water is repurposed for providing essential moisture to our gardens and landscaped areas. Rainwater Harvesting: The college established rainwater harvesting systems designed to capture and store rainwater runoff from rooftops and other surfaces. 12 percolation pits strategically located throughout the campus facilitate the natural infiltration of rainwater into the ground, recharging the local groundwater table and promoting long-term water sustainability.

## e-waste Recycling:

The e-waste includes out of order equipment/obsolete items like lab instruments, circuits, desktops, laptops, accessories, printers, network cables, Wi-fi devices, sound systems, display units, UPS, Biometric Equipment etc. These waste materials are mostly disposed of through buyback system and other items are cleared through collaborated certified e waste recyclers.

Instead of changing the CPUs the up gradation is done changing the mother boards or adding SSDs to minimize the boot time. Each system is utilized more than its shell life.

#### Hazardous chemicals and Radioactive waste management

The college recognized the importance of effective hazardous chemicals and radioactive waste management as part of our commitment to environmental safety and sustainability. The college has implemented comprehensive procedures to ensure the safe handling, disposal, and minimization of hazardous materials generated within our facilities, particularly in chemistry laboratory. In all chemistry laboratories fume hoods are placed to avoid students from exposure to hazardous gases.

The institution is always at the forefront in waste management emphasizing the three Rs-Reduce, Reuse and Recycle. The green cover on the campus is a feast to the eye. The landscapes in the campus add beauty to the institution.

#### **Built Environment with Ramps and Lifts**

A well-designed physical infrastructure ensures that individuals with mobility challenges can navigate campus spaces with ease to support individuals with mobility challenges. The campus infrastructure is designed with strategically placed 12 ramps and 3 lifts, allowing seamless access to classrooms, libraries, administrative areas and other facilities. These ramps and lifts follow standardized accessibility

guidelines to accommodate wheelchairs, walkers and other mobility aids, enabling smooth and independent navigation throughout the campus.

### **Divyangjan-Friendly Washrooms**

The washrooms are also located strategically around campus to ensure convenient access from classrooms, libraries and other common areas. **Non Visual Desktop Access (NVDA)** is a free open source globally accessible screen reader for the blind and vision impaired. This software is designed by the blind for the blind. This software provides access to technology no matter which language, location or situation believing that every blind or visually impaired deserve the right to freely access a computer.

NVDA allows blind and vision impaired people to access and interact with the Windows operating system and many third party applications.

• Support for popular applications including web browsers, email clients, internet chat programs and office suites, Built-in speech synthesizer, Reporting of textual formatting, Automatic announcement of text under the mouse and optional audible indication of the mouse position, Support for many refreshable Braille displays, with a Braille keyboard and Windows Command Prompt and console applications

The provision of arranging scribes for needy students are available in the college and such students are given extra time to complete the examination. Staff and students are always ready to help such students and ready to be present at their rescue.

# **Response:**

1. Title of the practice: Mentor – Mentee System

The mentoring system at Parvathaneni Brahmayya Siddhartha College of Arts & Science, aims to provide comprehensive support to students, addressing their academic, psychological, and professional needs.

## 2. Objectives of the practice:

- To improve the personal rapport between teacher and the student.
- To enhance academic performance and provide personalized academic guidance.
- To identify the strengths and weaknesses of the students and help them improving the former and overcoming the latter.
- To develop essential skills for professional and personal growth.
- Empathy towards students improve the counselling impact in bringing the expected change in the mentees

#### 3. Context:

A substantial proportion of the college's students are first-generation learners. They originate from modest beginnings and typically have a deficiency in proper guidance and motivation. The Mentor-Mentee system has been designed as a means of guiding the students from inception till completion.

#### 4. The Practice:

Under this system, a batch of students, not exceeding 30 is assigned to a teacher on their admission to I year UG/PG programmes. The teacher is designated as mentor and entrusted with the responsibility of mentoring the mentees throughout the duration of the programme.

#### **Level 1: Faculty-Student Mentoring:**

Assigned students are mentored for academic and career guidance. Every mentor is given **well designed mentoring books**, to post all the details of the mentee (i.e.) internal and external marks of all semesters, attendance and personal details along with photographs. Personal one to one meetings are conducted regularly to explain the academic progress, and find a solution to personal issues by counselling.

# **Level 2: Training and Orientation:**

As a part of **organisational commitment**, Mentors are given orientation to the Mentoring Process, Importance, Expectations, and Goals. All the faculty members have undergone the psychometric Analysis by TALENT METRIX.

# **Level 3: Professional Counseling:**

To offer timely support for all students regular psychological check-up was conducted in a proactive way to promote psychological balance, identify challenges early by Certified Analysts/Psychologists

## 5. Evidence of success:
