# Scholarship Policy

# Financial Assistance to Needy Students

- 1. College fee concessions are given to needy and deserving students on the basis of their performance in the last examination taken. Students desirous of getting such concession are required apply to the College office on the prescribed form.
- 2. Students belonging to scheduled castes, scheduled tribes and other backward classes, recognized as such by the Government of Andhra Pradesh/India, are awarded scholarships. Such students are required to apply to the State Government concerned on forms prescribed by the respective states, through the Principal immediately after joining the college.

## **GENERAL GUIDELINES**

- These scholarships shall not be disbursed, if the eligible candidates are not available.
- The decision of the committee related to the matters of the scholarships shall be final.
- The finance section shall process the approved scholarships and ensure the timely disbursement of scholarships.
- The details of the scholarships shall be accounted periodically and duly audited.
- Grievances, if any, will be addressed by the Grievance Redressal Committee.
